## CONDITIONS OF SALE

1. The highest bidder shall be the purchaser, provided that such bid has reached the reserve price and on the fall of the hammer a **\$500** deposit must be paid.
2. The vendor reserves the right to bid for any lot.
3. Time shall be the essence of the sale.
4. The auctioneer may without reason refuse to accept the bid of any persons and may decline an offer for any lot or withdraw any lot from sale.
5. Should a dispute arise on any bid, the relevant lot or lots may at the opinion of the auctioneer be put up again and resold.
6. At the discretion of the auctioneer every bid shall be at least 5 percent in advance of the previous and no person may retract a bid once made.
7. Upon the fall of the hammer each buyer shall pay in cash a deposit of not less than FIVE HUNDRED DOLLARS (\$500) the balance shall be paid in cash or by certified bank cheque payable to ABERDEEN AUTO AUCTIONS within 48 hours of the completion of the auction. No personal cheques accepted for settlement.
8. Where dates of payment or collection fall on a Saturday, Sunday or public holiday, the nearest working day following shall be the day on which the conditions of sale apply.
9. As all of the lots have been available for inspection prior to the commencement of the auction, no allowance or refunds will be made, nor will any buyer be permitted to reject any lot on the grounds that it is not correctly described in the catalogue. While due care and attention is taken during the preparation of the catalogue, the said lots are purchased with all faults at the buyer's risk on the fall of the hammer.
10. The vendor accepts no responsibility for the safe-guarding of goods stored at the auction site and shall not be liable for any loss or damage to the goods whether such loss or damage is caused or contributed to by any act of vandalism or through the neglect or default of the vendor, its servants, employees or agents.
11. Goods not collected by the specified times may or without prior notice to the purchaser and without prejudice to any other rights of the vendor, be resold by the vendor. All associated resale costs and charges shall be incurred by the original purchaser.
12. Care is taken to provide accurate descriptions of all lots however no responsibility is accepted. Buyers should satisfy themselves prior to sale as to the condition of each lot and should exercise and rely on their own judgment as to whether the lot accords with its description. None of the vendor, Auctioneer, their servants, employees or agents are responsible of errors of description or for the genuineness or authenticity of any lot. No allowance or refunds shall be made nor will any buyer be permitted to reject any lot.
13. The vendor or auctioneer shall not be responsible for any accident to any worker or any other person sustained during the removal of any of the items, or during the period of inspection or sale. Members of the public attend at their own risk.
14. All cheques and all other monies outstanding at the end of the auction are to be made payable to ABERDEEN AUTO AUCTIONS.
15. The vendor makes NO WARRANTY whatsoever for any lots purchased at auction where those **vehicles are private consignments or finance company repossessions**. While all care is taken in the preparation of vehicles, it is the purchaser's responsibility to ascertain the condition of any vehicles prior to the commencement of sale.
